



2019 Summer Enrichment Information and Enrollment Packet

We are planning a fantastic fun-filled summer here at Ashley Academy! Extended care is offered starting the week of May 28 and it will end the final week of August 12. Eight weeks of enrichment camps will be intermingled with the extended care events to create an endless array of activities. Review the following pages for more detailed information on both.

Summer Camps *(begins Monday, June 10):*

Summer Enrichment Camps will be offered for eight weeks starting on June 10 and ending the week of July 29. Each week a camp for three different age groups will be offered (3-5 years, 6-9 years, & 9-14 years, *unless otherwise indicated*) and a detailed description of each camp is available in this packet. Enrichment camps are Monday through Friday from 9:00 a.m.-12:00 p.m.

Extended Care *(begins Tuesday, May 28):*

In addition to summer camps, the Extended Care program will be offered for children enrolled at Ashley Academy, as well as those from the community. The hours of operation are from 7:30 a.m. - 6:00 p.m. There is no extended care during the summer camp hours of 9:00 a.m. -12:00 p.m. The staff has planned special activities and events each week from 12:00 p.m. – 6:00 p.m. for the children with a guarantee they will not think about school during their attendance. The children may also participate in the age-appropriate camps during the five different weeks they are offered. (See Extended Care Camp Sheet for detailed information.) For those interested in summer care, please select the column labeled, "Camp & Extended Care" for the preferred weeks. A drop-in rate is available for extended care only from 12 p.m. - 6 p.m. during camp weeks.

Registration:

Complete and return the attached registration form by May 13 to the front office. On the form there are choices for "Extended Care Camp" when camp is not offered, "Camp Only", "Camp and Extended Care," or "Extended Care Only." The cost for each option is listed on the registration form. Snacks are included in the amount for all three options but children will need to bring a packed lunch if staying for Extended Care in the afternoon. Early registration is recommended due to small class sizes. We will inform you of any changes or cancellations.

Preschool children must be toilet trained to attend camp.

An email will be sent to each family to confirm a child's registration. Ashley Academy reserves the right to make schedule changes if necessary. If you have any additional questions please call 423-929-7888 or email mpeterson@ashleyacademy.com

Payment/Refunds:

Tuition payment for camps is due at the time of registration. We accept cash, checks, and credit cards. If you would like to use a credit card, please contact Amy Weber, Business Manager, at aweber@ashleyacademy.com to process the payment. If a registration must be cancelled by the parent, a one week notice must be given prior to the start of the selected camp to receive an 80% refund. Otherwise, no refund will be given. However, if a camp is cancelled due to low enrollment a full refund will be given to each registered participant. Refunds are not given for absences.

Arrangements can be made for monthly payments if a child is participating in multiple weeks of Camp and Extended Care. The initial payment for the first week (May 28-31) is due when the form is submitted. The remaining payments will be required by the first of each month starting in June. Arrival/Departure:

Children in camp will report to the gym between 8:50 a.m. – 9:00 a.m. to meet their teacher. Campers can arrive at 7:30 a.m. for an additional cost of \$10 an hour, unless the child is registered for Extended Care.

Children who attended camp but are not staying for Extended Care should be picked up at 12:00 p.m. in the gym. Otherwise, all remaining children will be sent to Extended Care for an hourly fee of \$10 unless other arrangements have been made.

Snack:

Snack will be provided at camp. Please see student information sheet for allergy information.

Lunch:

Children who are staying for Extended Care should bring a lunch from home each day.
